<b>Entry fees:</b>	<b>Entry fee: US\$150.00 per player.</b> Entry fees are to be paid in cash before beginning of tournament. If entry fees are not paid according to the regulations, the players concerned are not allowed to play. The member association that enters a player into a circuit tournament is responsible for paying the entry fees for that player.

<b>Transportation:</b>	<p>The Organizing Committee will offer transportation from <b>J.A. Pengel Airport</b> to the official hotels, however, only those who are staying at the official hotel can use the transportation. <b>Parents, family and companions staying at the official hotel may also use the transportation for a one-time fee of US\$ 30 per person.</b> The Organizing Committee will also offer transportation from the official hotel to the venue (only for those staying at the hotel). In this transport, the priority is the players and coaches. If necessary, the family should wait for another transport.  <b>Transportation services will be offered only in the period from 12 to 16 November 2019</b></p>
<b>Uniforms:</b>	<p>According to BPAC regulations, for all tournaments the player's name and the country on the back of the shirt is mandatory (BWF GCR, refereeing player's clothing, designs, advertising and lettering). Take note that the name of the player on the back of the shirt must comply with the name registered on BWF – player's data base.</p>

<b>Doping Control:</b>	<p>Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.</p> <p>Athletes are responsible for any substance found in their body.
