Regulations for Continental Pan American Badminton Championships, item 6 will be followed regarding Competition System.

Male Team size: Up to ten (10) Male entries, minimum of four (4) Male players

Female Team size: Up to ten (10) Female entries, minimum of four (4) Females players

Male Team composition

for a tie: Five matches make a Tie (three MS and two MD)

Order of play: Will be decided by the Referee, once Tie team format is due.

Female Team composition

for a tie: Five matches make a Tie (three WS and two WD)

Order of play: Will be decided by the Referee, once Tie team format is due.

First stage: Group play (all five (5) matches must be played)
Second stage: Knock-out system (Best three (3) matches)

Anti-doping:

Anti-doping will be conducted in accordance with BWF and WADA regulations. Please consult the BWF website for further information, and to view the current WADA Prohibited List.

Please note that athletes must complete a TUE application process to apply for authorization to take medications which fall under the Prohibited List – before they take medication.

Doping Control

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

Badminton Integrity

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.
