Entry fees:

If entry fee are not paid according to the regulations, the players concerned are not allowed to play. The member association that enters a player into a circuit tournament is responsible for paying the entry fees for that player.

Withdrawals:

Please ensure that the organizers are informed immediately when a player has to withdraw, together with the reason.

Attention: Any withdrawal after the Sunday immediately preceding the draw, for any reason whatsoever, renders the Member Association concerned liable to an amount of \$ 150,00 for the inconvenience caused by the withdrawal (as defined in BWF General Competition Regulations).

Final Date to withdrawals without penalty Monday, June 16th, 2025 until 23:59h BWF HQ (GMT +08:00h) Kuala Lumpur – Malaysia.

Uniforms:

According BPAC regulations, for all tournaments that are part of the Pan American Circuit **the player's name and the country name or code on the back of the shirt is mandatory.** (BWF Statutes, Section 5.1 GCR 20-24, Player clothing and equipment, referring to player's clothing, colours, designs, advertising and lettering)

Transportation:

FESALBAD: will offer transportation from the airport to the hotel and will offer transportation from the hotel to the venue, only for bookings at the Official Hotel.

Bus schedule will be set up according to competition schedule.



Medical service:

A doctor and a physiotherapist will be at the venue during the practices and while matches are on (according to the Pan Am regulations 23.1)

Doping Control:

Doping control in badminton, in accordance with BWF AntiDoping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

Anti-Doping Control:

Anti-Doping will be conducted in accordance with the BWF and WADA regulations. Please consult the BWF website for further information, and to view the current WADA Prohibited list.

Please note that the athletes must complete a TUE application process to apply for authorization to take medications which fall under the Prohibited List – before they take medication.

Doping Control, doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out of competition and in- competition with the collection of urine an/or blood samples.

Athletes are responsible for any substance found in their body.

Before and athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption
