### ENTRY FEE:

**Cost: \$150.00 USD**

Entry fees are to be paid in cash in advance of the tournament, or at the time of registration. The Member Association that enters a player/pair into a BWF tournament is responsible for paying the entry fees for that player/pair. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes.

### WITHDRAWALS:

Please ensure that the organizers are informed immediately when a player has to withdraw, together with the reason.

Attention:

Any withdrawal after the Monday immediately preceding the draw, for any reason whatsoever, renders the Member Association concerned liable to an amount of \$150,00 for the inconvenience caused by the withdrawal (as defined in BWF General Competition Regulations).

**Final Date to withdrawals without penalty Monday, July 1<sup>st</sup> 2025**, until 23:59h BWF HQ (GMT +08:00h) Kuala Lumpur - Malaysia.

### UNIFORMS:

According to BPAC regulations, for all tournaments that are part of the Pan American Circuit **the player's name and the country name or code on the back of the shirt is mandatory.** (BWF GCR, referring player's clothing, designs, advertising and lettering)

### TRANSPORTATION:

Bus schedule will be set up according to competition schedule for those using the tournament official hotels.



### **MEDICAL SERVICE:**

A doctor and a physiotherapist will be at the venue while matches are on.

### **DOPING CONTROL:**

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out of competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

### **BADMINTON INTEGRITY:**

Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in

any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es).
