If no objection is received by BWF by Thursday, 6 November 2025 at 23:59 hrs BWF Headquarters time, the entries shall be deemed to be correct. No complaints/objections will be entertained after this point.

Entry Fees for international players will be as follows:

- \$215 USD per player

All payments must be made prior to the start of competition. Member associations can make payment via bank transfer upon request to bmerrett@badminton.ca, payable to Badminton Canada by December 1st, 2025. Badminton Canada must receive confirmation of payment prior to athletes receiving their accreditation.

Online Entry – Hosting Member Association Entries

Eligible players wishing to enter through the hosting Member Association must follow a different process for international entries.

- Entry is open to any current member of Badminton Canada in good standing with a BWF # ID number. Please note that only Canadian players with a BWF # ID registered in the BWF Active Player Database can be entered by Badminton Canada. Badminton Canada is implementing its Online Entry System for this tournament.
- All Canadian Players must hold a valid National Level licence with their province of residence.
- All Canadian players will be required to pay a Canadian Insurance and Anti-Doping (CIAD) fee as requested by Badminton Canada. Both a valid National level licence and the IAD fee must be paid the time of online registration.
- Players who intend to register for this tournament must ensure that they have a working email to receive a payment and entry confirmation email via tournament software.

Entry Deadline:

The entry deadline for Badminton Canada members is **Sunday November 2nd 2025 at 2359 hrs. PST**. No late entries will be accepted.

Entry Fee:

- Flat entry fee of \$160 CDN
- Administrative fee of \$15 CDN



Confirmation of Entry & Payment:

- Registering players will receive an email confirmation generated by the Badminton Canada Online Entry System and it will include: the events entered and for doubles, partners selected as well as the amount paid online.
- Receipt of payment and entry confirmation email is the conclusive evidence of receipt of entries before the deadline.

Refunds:

- No refunds will be made for withdrawals done after the deadline of Monday, 3 November 2025
- Entry fees will only be refunded for non-placement in the draws.

Canadian Entries:

- Canadian entries will be entered into the draws in order based on: BWF ranking, Badminton Canada ranking and random draw by BWF.
- Placement in the draws, including qualifications, is not guaranteed due to the maximum entry limits.

Withdrawals

The management of withdrawals will be run in accordance with BWF GCR 13 and 14.

Member Associations can withdraw their entries through the BWF Online Group Entry system until the last date of withdrawal without penalty (see Key Dates Section).

Withdrawals made after this date will incur a penalty in accordance with the BWF Table of Offences and Penalties (BWF Statute 2.5).

Please ensure that the Tournament Referee and Host Organizer are notified immediately in writing, clearly stating the reason for the withdrawal.

A limited number of additional accreditations for approved Team Officials will be available for purchase at a fee of USD\$150, charged to the respective Member Association, and payable at the tournament.

The fee to replace any lost or damaged accreditation passes will be USD\$100 on each occasion, charged to the respective Member Association.

The tournament reserves the right to refuse entry into any accredited venue or area or service (e.g. transportation) as a result of damaged or missing accreditation.

The fraudulent use of accreditation is strictly prohibited, and will result in access rights being removed, and penalties being applied.

Individuals staying at the Tournament Hotel will receive a special pass for tournament transportation.

Medical Services

Any request for Covid-19 PCR or blood tests for pre-departure will be charged to the individual requesting the test. Fee: \$100 USD

Anti-Doping

Anti-Doping will be conducted in accordance with the BWF and WADA regulations. Please consult the BWF website for further information, and to view the current WADA Prohibited list. Please note that the athletes must complete a TUE application process to apply for authorization to take medications which fall under the Prohibited List – before they take medication.

Doping Control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out of competition and in- competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption
