2. Entry Details

Regulations (Conditions of Play)	This tournament will be run in accordance with, but not limited to, the Badminton World Federation (BWF) Statutes, General Competition Regulations (GCR), General Competition Regulations (GCR), Badminton Pan Am Regulation (BPAC) and CC Grade 3 Tournament Regulations. In the event of any dispute, the decision of the Tournament Referee will be final.

For all tournaments included in the Pan American Badminton Circuit, **the name of the player on the back of the jerseys and the name of the country are mandatory** and must be in accordance with the BWF GCR regulations. This tournament will strictly enforce the Clothing, Equipment, and Advertising Regulations as outlined in BWF GCR 20–24. Any breach of these regulations will be forwarded to the BWF

It is mandatory that for all tournaments that are part of the Continental Tour all opposing players wear different colours significant for the quarterfinals, semifinals and finals (BWF GCR: 21. COLOUR OF PLAYERS' CLOTHING, 21.6).

Entry Fees

Entry Fees for international players will be as follows:

- **\$150 USD per player**

All payments must be made prior to the start of competition.

Withdrawals

The management of withdrawals will be run in accordance with BWF GCR 13 and 14.

Member Associations can withdraw their entries through the BWF Online Group Entry system until the last date of withdrawal without penalty. **Monday, August 10th, 2026 at 11:59 PM (GMT +08:00)**

Withdrawals made after this date will incur a penalty in accordance with the BWF Table of Offences and Penalties (BWF Statute 2.5).

Please ensure that the Tournament Referee and Host Organizer are notified immediately in writing, clearly stating the reason for the withdrawal.

If a Member Association needs to withdraw any entries once players have arrived in the host city, notification of withdrawal must be made by the Team Manager in person to the Tournament Referee, or Deputy Referee(s), and must also be confirmed in writing to:

<p>Presentation Ceremonies</p>	<p>All prize ceremonies will take place on Sunday (last day of the tournament), Sunday 23rd, August 2026 immediately after the conclusion of each final. Medals/trophies/other will be presented to all champions and finalists.</p> <p>In accordance with Player Commitment Regulations (BWF Statue 5.3.6), all players participating in the finals of a tournament must attend the final ceremonies directly after the match or must follow the instructions given by the organizers regarding ceremony protocol.</p> <p>No equipment, including rackets and flags, are allowed to be brought onto the podium. Clothing worn during the ceremony must be in accordance with the BWF GCR.</p>
<p>Accreditation</p>	<p>Access to Tournament venues and other services is provided through personalized and photographic accreditation.</p>
<p>Medical Services</p>	<p>A medical officer and physiotherapist service will be available during the tournament, free of charge to players.</p>





<p>Anti-Doping</p>	<p>Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.</p> <p>Athletes are responsible for any substance found in their body. 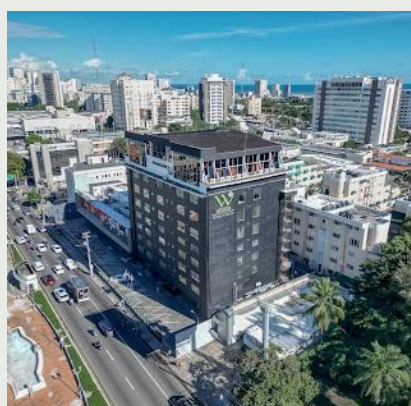
