Please see the key dates section for entry deadline. Late entries will not be accepted. For this tournament, the entry deadline is Tuesday, August 4th, 2026 11:59 PM (GMT +08:00).

Member Associations should contact BWF immediately if such notice is not received by **Wednesday, one day after the entry deadline at 23:59 hrs. BWF Headquarters time.**

If no objection is received by BWF **Thursday, two days after entry deadline at 23:59 hrs. BWF Headquarters time**, the entries shall be deemed to be correct. No complaints/objections will be entertained after this point.

Entry Fees

Entry Fees for international players will be as follows:

- **\$125 USD per player (No event)**

All payments must be made before the start of the competition, in cash only, using banknotes in good condition.

The event registration fee is payable in cash only before the start of the tournament. Failure to pay the registration fee according to the regulations will result in the affected players being ineligible to participate. The member association that registers a player for a tournament on the circuit is responsible for paying that player's registration fee.

The registration fee must be paid at the technical conference or before your match. Failure to pay the registration fee will result in ineligibility to participate.

Withdrawals

The management of withdrawals will be run in accordance with BWF GCR 13 and 14.

Member Associations can withdraw their entries through the BWF Online Group Entry system until the last date of withdrawal without penalty. Monday, August 24th, 2026 at 11:59 PM (GMT+08:00) Withdrawals made after this date will incur a penalty in accordance with the BWF Table of Offences and Penalties (BWF Statute 2.5).

Please ensure that the Tournament Referee and Host Organizer are notified immediately in writing, clearly stating the reason for the withdrawal.

If a Member Association needs to withdraw any entries once players have arrived in the host city, notification of withdrawal must be made by the Team Manager in person to the Tournament Referee, or Deputy Referee(s), and must also be confirmed in writing to:

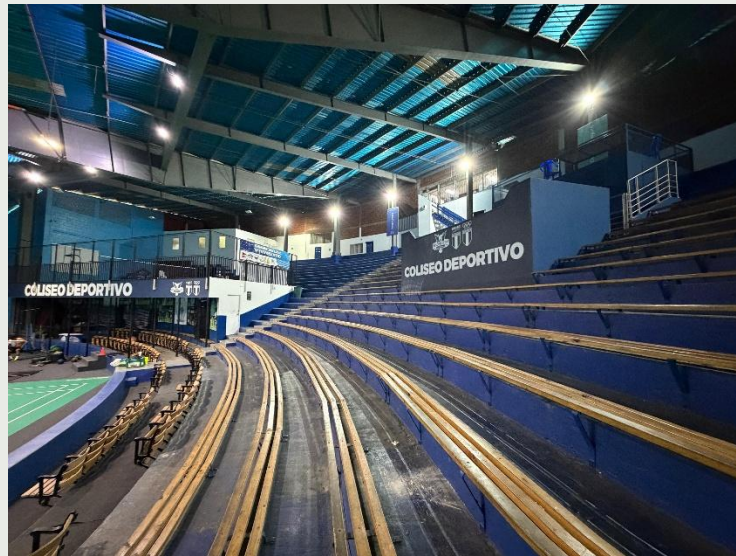
