## ENTRIES

Players cannot be entered unless they already have a BWF ID number. In case you wish to enter player(s) who do not have a BWF ID-number, each MA can create the ID through the Online Entry System. Entries must be submitted to BWF no later than **Tuesday March 23rd 2021 at 23:59h BWF Headquarters time (GMT + 08:00h). Late entries will not be accepted.**

## ENTRY FEES

**Cost:** \$ 150,00 per player

Paid in cash before beginning of tournament.

If entry fee is not paid according to the regulations, the players concerned are not allowed to play. The member association that enters a player into a circuit tournament is responsible for paying the entry fees for that player.

## VISA

For all player and officials, who require visa to enter Peru, should submit full passport details (Full name, Passport No, and Date of Issue & Expiry contact no.) to [badminton@badmintonperu.com](mailto:badminton@badmintonperu.com) later than March 16<sup>th</sup>, 2021

## UNIFORMS

According to BPAC regulations, for all tournaments that are part of the Pan American Circuit **the player's name and the country name or code on the back of the shirt is mandatory.** (BWF GCR, referring player's clothing, designs, advertising and lettering)

## TRANSPORTATION

The organization will offer transportation from the airport to the official Hotel, and the venue, **only when booking for the Official Hotels.** Bus schedule will be set up according to competition schedule

## MEDICAL SERVICES

A doctor and a physiotherapist will be at the venue while matches are on.

## MEDICAL INSURANCE

To be arranged individually by participants.

## DOPING CONTROL

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

## BADMINTON INTEGRITY

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of matches.

## COMPLIANCE WITH GENERAL COMPETITION REGULATIONS CLAUSE 7.9

GCR 7.9: "In making or authorizing entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."

## COVID-19 CONSIDERATIONS

Every participant is responsible for providing their negative test result for COVID-19, which is required by the Peruvian Government to enter the country. The organizing committee (OC) will conduct mandatory COVID-19 tests to every participant upon arrival. The OC can offer one single accommodation option at Villa Deportiva Nacional (VIDENA), where the venue is located, due to restrictions imposed by the regulations established by the National Sports Institute and the Peruvian Government. The OC can suggest other accommodation options nearby the venue upon request; however, any participant not staying at the official hotel shall comply to greater restrictions within the venue, like restricted areas for those coming from outside, in order to guarantee everybody's safety, and others to be established by the OC during the competition period. Protocols are to be published separately.
