1 Para Badminton Events Combination Chart

- 1.1 The chart below is a reference to the distribution of para badminton world ranking points when events are combined for competition when Para Badminton General Competition Regulations 11.1.6 applies.
- 1.2 In the combined events described below, a player may only form a partnership with one other player. A team representative present at the team managers meeting for draw management shall decide which pair shall play in the combined event
- 1.3 When different classes are combined, the class with the higher number included in the class name is called the 'less impaired class' and the class with the lower number included in the class name is called the 'more impaired class'
